It gives me great pleasure to meet you online for the ITMF Textile Machinery Workshop 2021. On behalf of the ITMF, I would like to extend my hearty welcome and warm greetings to friends old and new.

To date, the world is experiencing the combined impacts of major changes and a pandemic both unseen in a century. The international community is being tested by the battle between multilateralism and unilateralism. The global economy is on a long and bumpy road to recovery with many turns and twists. As a highly globalized sector in the world, textile and apparel industries have been moving in the same direction, bearing the brunt of the intense volatility in raw material prices and freight rates, and managing profound changes in economic structures, public policies, and international rules. Going forward, there are growing complexity and heightened uncertainty facing the industries.

Multilateralism and concrete actions are the sure way to rise to almost any external challenge. At the ITMF, we always have been and always will be upholding the spirit of mutual respect, mutual trust, and mutual benefit, and following the principle of extensive consultation, joint contribution, and shared benefits, committed to playing a constructive role in sustainability and shared prosperity of textile and apparel industries worldwide.

**First, pursue sustainable development and work in solidarity to build resilient and safe industrial and supply chains.**

At the ITMF, based on data and analysis, and best practice sharing,

we have spurred interactions across different regions and between upstream and downstream industries, to explore ways for greater policy coordination and standard harmonization. This year, we became a signatory of the position paper regarding REACH Restriction Proposal on Skin Sensitizers. In parallel, we are pressing on Payment & Delivery Terms Initiative launched by STAR-Network and GIZ, and by working with OECD, we are participating in conversation and consultation on the impact of policy changes and stakeholder actions on our industry and enterprises.

**Second, embrace inclusive and green development to foster a community with a shared future for mankind and Nature.**

At the ITMF, we continue to steer the industrial development toward a new stage of equitable, effective, balanced and coordinated growth, facilitating the implementation of the 2030 Agenda for Sustainable Development. To be specific, we step up the international cooperation to secure supplies of medical textiles in response to the COVID-19 pandemic and its consequences; we push for innovation, practice, and adaptation to climate in the industry based on the principle of common but differentiated responsibilities and support the industry's green transition by taking the lifecycle thinking and approach. Climate Change has already been a central issue on the ITMF agenda by which industrial consensus and rules are being developed and formed.

**Third, stay true to innovation, openness, and shared success to shape a better ecosystem for high-quality development.**
